REPORT OF THE CONGREGATION COUNCIL PRESIDENT

Fortunately for all of us, the transition in this area is going well. We have a very capable Call Committee in place, led by Kathy Good and supported by Pastor Strause. You will hear more about the committee's work during the meeting.

Of course, everyone is familiar with the new transition we are currently facing, the resignation of Cantor Chris Prestia. Chris has shared the reasons for his move from Good Shepherd and we only wish him the very best in his future endeavors. His departure leaves us with multiple questions which need to be addressed. Council has decided rather than move ahead with looking for a replacement Cantor, we would place that decision on hold until we have a new Pastor and enable that individual to help us discern the path forward for our music ministry. At the appropriate time, we will convene a group to evaluate our needs and fiscal levels to guide us on our musical journey.

Of course, we can not be without music during our worship. As previously announced, we are extremely fortunate to have Mrs. Valerie Lefever-Hughes to lead us in music as the Director of Music. Valerie brings not only highly developed musical skills and talent, she also brings a long history of worshiping in our congregation. So actually, the transition process of changing from one state or condition to another is being well managed here at Good Shepherd. We ask for your prayers and support as our groups work for the benefit of us all.

Our Financial Task Force continues to work on options and plans to guide us through these challenging times. Many members heard their words at our last meeting, and for the first three months of 2024 our offerings have increased. Some people have elected to give their annual pledges early in the year to help us through the challenges. We understand this is not for everyone, nor do we expect it. Our general statement of caution is everyone will continue to remain engaged and pro-active in their financial support of the church.

We have seen wonderful examples of expanding relationships, the return of Mardi Gras Tuesday for one. Our turnout was wonderful and a group of fantastic people came together to make it work. These connections makes everyone feel energized; something long needed after our changes due to Covid.

Remember, the opportunities for you to be engaged are numerous. Whether it is our long-standing Senior Shepherds group or one of our new Small Groups, we have something for everyone. The groups need you to be successful and flourish. Please reflect on how your involvement could benefit you!

REPORT OF THE INTERIM PASTOR

REV. KURT K. STRAUSE

"In the meantime" is an expression often used to designate the passage of time between the conclusion of one event and the anticipated start of another. A professor of mine at seminary described the now two-thousand year Age of the Church as the "meantime" between the Ascension of Jesus and his coming again at the end. He liked to say this period of time could be a truly "mean time," meaning it is often filled with as much woe, calamity, and hardship as it is blessings and peace.

That's not how I would describe the "meantime" between the retirement of your previous pastor and the anticipated call of your new pastor. I have experienced the past eight months as a time of much blessing, peace, and grace. The congregation welcomed me as your interim pastor and together we have worked through this time of transition with a great deal of openness, support, and good will. I would call this a truly "grace-filled time."

I began my work with you simply getting to know the congregation, its leadership, staff, and ways of doing things. I conducted a series of one on one and small group interviews in which you told me stories of your involvement in the congregation, how you came to be here, and what excites you about the ministry. I led a series of adult forums to describe the call process, hear about the past ministries of Good Shepherd and its predecessor congregations, and discern the "core values" that inspire and motivate the mission of this community of Jesus' disciples.

Those core values I discovered are rooted in "living out the unconditional love and radical hospitality of Jesus in worship, service, and shared life." The people of Good Shepherd demonstrate their commitment to embodying what is more than a mission statement on a piece of paper. The integrity of maintaining high standards of Lutheran liturgical worship and the welcoming hospitality shown to all people will be the kind of values that will motivate a new pastor to lead you into the next era of your mission.

Now a Call Committee has been organized and is hard at work in developing a Mission Site Profile for the congregation. Once completed they will begin the work of engaging in mutual conversations and discernment with candidates for pastor. As the Holy Spirit leads you will issue a call to your new pastor.

"In the meantime" I continue to look forward to serving you in this season of transition, leading you in worship, service, and hospitality as you continue to seek to follow our Lord in the ways of radical hospitality.

MINUTES SEMI-ANNUAL MEETING ON NOVEMBER 19, 2023

Call to Order:

Mike Young, Congregation Council President and Presiding Officer, called the meeting to order at 11:08 a.m.

Prayer:

Pastor Kurt Strause led the congregation in prayer.

Adoption of Minutes from Congregational Meeting of April 30, 2023:

A motion was made by Cheryl Laub and seconded by Randy Patterson to accept the minutes. Motion passed unanimously.

Approval of Budget:

Mark Lowery made a budget presentation using the attached handout, "Financial Update and 2024 Budget." He discussed the current financial condition and the 2024 spending plan overview. It was stated that there is a negative balance of ~\$70,000 as of this meeting with a downward trend in giving. A question period resulted in the following answers:

- The number of giving units has dropped from 214 in 2022 to 189 in 2023, and giving amounts have also dropped.
- There is a need for prayerful giving from the congregation to fill in the budget gap and prevent a gap in the future. The need is immediate.
- Pledged giving is encouraged.
- There is a need to communicate the budget to the wider congregation. The committee will monitor and supply monthly updates in Good News.

Mark Lowery invited members to share any ideas regarding the budget.

A motion was made by Kathy Good and seconded by Chuck Book to approve the budget, which passed unanimously.

Approval of Nominating Committee:

A motion was made by Becky Marks and seconded by Kris Albert to approve the Nominating Committee as listed below. Motion passed unanimously.

He encouraged all to "give with joy."

From that book club the Good Shepherd Creation Care Team was formed. The core group of five women has remained together, and over the years we have welcomed several others who have joined us as they had the time or were able. We may be a small group of Earth warriors, but we are connected to many organizations by which we collaborate and use as resources. Interfaith Partners of the Chesapeake is our go-to organization for all things Creation Care.

Winter is a time for all of nature to rest. The Creation Care Team also uses the darker days of the winter months to recharge. These last few months we have spent time reading and studying "Braiding Sweetgrass" by Robin Kimmerer. We have also been planning for the blessing for the new Rain Garden at Good Shepherd (April 14th), planning our Adult Forum class for April 7th-"One Bowl, One Spoon" - a concept in "Braiding Sweetgrass," and finally planning the Intergenerational Family Activity - Good Shepherd Family Fun - on Wednesday, April 17th with a theme of FIRE! - another indigenous concept found in "Braiding Sweetgrass."

As you can see, this book was a special read for us. Now that Spring and Summer are upon us, the next part of this year is our busy time as we look forward to taking part in county-wide tabling events at eco-fairs. REPORT OF THE ENDOWMENT COMMITTEE

The Endowment Committee includes six members at large with staggered three-year terms, plus the President of the Congregational Council, the Finance Committee Chair and the Interim Pastor.

The Committee is charged with managing the Endowment Funds in a manner consistent with the Investment Policy established by the Congregational Council, and with the reporting of all activity in the Endowment Funds to the Council on a regular basis. Distribution of funds from any Endowment Account is subject to the guidelines established in the Endowment Committee Policy by the Congregational Council. The Endowment Committee is also charged with providing information and educational opportunities to the Congregation related to financial and endowment matters.

The Feeding Ministries Small Group was started last year in the month of June. Here is a summary of the feeding events over the past year.

- At the end of last year, the Turkey Box Tuesday and Thanksgiving In-person Dinner were held in November
- On "Souper Bowl" Sunday, people donated quarts of soup that were given out after the Sunday church service
- Also in February, 10 church volunteers packed 360 food boxes at the Power Packs warehouse that were sent home to local school students
- During the Sundays in Lent, food was collected and then given to the Conestoga Valley Christian Community Services
- We continue the preparation and serving of a monthly Grace Meal
- The Helping Hands Ministry continues to help those in our congregation who, due to hospitalization or sickness, are in need of a meal
- We help with receptions at church
